A career-oriented panel discussion will be held each Friday, over a catered lunch, followed by a reception with the speakers. Hosted by leaders in the sports industry, the weekly career panels offer students valuable insight to the profession, along with priceless networking opportunities.

On Monday and Tuesday nights, we will screen documentaries from ESPN's award-winning "30 for 30" and "Nine for IX" series on the world of sports, after which we'll discuss the meaning and import of the issues presented. On Wednesdays, we'll organize a softball or soccer game or a tennis match. And each morning, anyone who is interested can join an optional group "fun run" in and around the Oregon campus. On the weekends, we'll take you on a white water rafting trip down the picturesque Rogue River, and up to Portland for a Timbers soccer game and tour. We'll top it all off with tours of Oregon's state-of-the-art athletic facilities, including the innovative Football Operations Center, as described by Sports Illustrated.

- Resume

- Certification of enrollment with your current law school
- Whether you intend to lease an apartment through the Skybox
- \$50 application fee

#### **Costs:**
